TERMS AND CONDITIONS OF MEMBERSHIP

1. Applicant agrees to pay a non-refundable registration fee of \$_____.
2. Applicant agrees to pay monthly dues of \$_____ upon receipt of the bill each month, such dues being delinquent after the fifteenth (15th) of each month and will continue to pay dues and any charges incurred until termination of this membership. Dues may be increased upon thirty (30) days notice.
3. Applicant shall be fully responsible and liable to the Center for all obligations incurred and/or owed to the Center by any person entitled to the use of the privileges of the Center under this membership.
4. Guests will be allowed provided they are registered by the member at the Front Desk, and have signed the Release and Waiver of Liability and Indemnity and the appropriate guest fee is paid. Guest rules and regulations are found in the **RULE BOOK**.
5. *Adult and Spouse Memberships are reserved for a legally married couple only.
6. The Center reserves the right to refuse service to any holder of a membership and all persons entitled to the privileges under this membership whose conduct is in breach of any of the terms and conditions of the Center.
7. All memberships are personal licenses, which shall permit the holders the revocable right to use the Center facilities. It is expressly agreed and understood that the holders of licenses in the form of memberships shall neither individually nor collectively have any propriety rights or interests in or to any of the properties, assets, premises or any other thing or matter whatsoever in respect to the Center or its facilities or operation of the Center. The license is not assignable or transferable.
8. A holder of a membership may resign at any time by submitting a written notice to the Center (mailed to: Peninsula Community Center Attn: Membership, 3560 Farm Hill Blvd, RWC, CA 94061) of the intention to do so and meeting all of the following conditions:
 - a. Written notice of termination of membership has been received by the Center **thirty (30) days in advance**.
 - b. Any and all indebtedness has been paid in full or an acceptable payment schedule between the member and the Center has been agreed upon in writing.
 - c. All items have been removed from any rented locker(s).
9. The privileges of membership will not carry any right to income or earnings of the neither Center, nor will it, or its holders, is liable for any of the debts or obligations of the owners or operators of the Center. The privilege of membership will carry no right or participation in the management or control of the finances of the Center or any of the facilities.
10. Peninsula Covenant Church reserves the right to revoke any or all membership privileges at any time at its sole discretion by given written notice of revocation to the holder of the membership.

RELEASE AND WAIVER OF LIABILITY AND INDEMNITY

Member and any Guest of Member hereby acknowledges and agrees that their use of facilities, services, equipment or premises and their participation in programs, outings and events whether on or off the premises of Peninsula Community Center (PCC) may involve risk of injury to persons and property, including those described below, and Member and any Guest of Member assumes full responsibility for such risks. In consideration of being permitted to enter and/or participate in activities of Peninsula Community Center for any purpose including, but not limited to, observation, use of facilities, services or equipment, or participation in programs, events and outings in any way, whether on or off the premises of Peninsula Community Center, Member and any Guest of Member agrees to the following:

Member and any Guest of Member hereby releases and holds Peninsula Community Center (PCC) and Peninsula Covenant Church (PCC) and their directors, officers, employees, affiliates and agents harmless from any and all liability to Member and Member's personal representatives, guests, assigns, heirs, and next of kin for any loss or damage of whatsoever nature to Member or any guest of Member.

Member and any Guest of Member hereby expressly waives any claim of liability for personal/bodily injury or damages of whatsoever nature or kind which occurs to member or any guest of member and for any loss of or injury to person or property of whatsoever nature whether on or off the premises of PCC. This waiver includes, but is not limited to any loss, damage or destruction of the personal property of the Member of any guest of any Member and is intended to be a complete release of any responsibility for any personal injuries and/or property loss/damage sustained by any Member or any guest of any Member whether on or off the premises of PCC.

Member and any Guest of Member also hereby agrees to indemnify Peninsula Community Center (PCC) and Peninsula Covenant Church (PCC) and their directors, officers, employees, affiliates from any loss, liability, damage or cost incurred as a result of any claim of whatsoever nature made by Member, Member's agent or Member's guest.

Member represents (a) that Member is in good physical condition and has no disability, illness, or other condition that could prevent Member from exercising without injury or impairment of health, and (b) that Member has consulted a physician concerning an exercise program that will not risk injury to Member or impairment of Member's health. Such risk of injury includes (but is not limited to): injuries arising from use by Member or others of exercise equipment and machines; injuries arising from participation by Member or others in supervised or unsupervised activities or programs at PCC; injuries and medical disorders arising from exercising at PCC such as heart attacks, strokes, heat stress, sprains, broken bones, and torn muscles and ligaments, among others; and accidental injuries occurring anywhere in PCC dressing rooms, showers and other facilities and including injuries off premises relating to a PCC activity. Member and Member's guest acknowledges that PCC has not and will not render any medical services including medical diagnosis of Member or Member's guest's physical condition.

Member agrees that if any person outside Member's family brings Member's children to PCC or an off premises event affiliated with either PCC, Member agrees to instruct that person to sign a waiver releasing, indemnifying and holding PCC, its agents, employees and affiliates harmless from responsibility and liability for any injury they may sustain while on the property of PCC.

In addition thereto, Member agrees to be financially and legally responsible for any injury or illness that should occur to them while they are in charge of Member's children at PCC.

Member further understands that Member or Member's insurance carrier will assume full responsibility for all payments and costs of any emergency treatments for Member's family, guests, or caregivers of member's children.

If member is absent in the event of any emergency regarding Member's children or spouse, member hereby authorizes _____ as the emergency contact person or, alternatively, an adult leader of program, as agent for me, to consent to any necessary medical treatment advised and supervised by a physician, surgeon or dentist (as appropriate) licensed to practice under the laws of the state where the services are rendered.

Member further expressly agrees that the foregoing release, waiver and agreement is intended to be as broad and inclusive as is permitted by the law of the State of California and that if any portion thereof is held invalid, it is agreed that the balance shall, notwithstanding, continue in full force and effect. Member has read this release and waiver of liability and indemnity clause, and agrees that no oral representations, statements or inducement apart from the foregoing written agreement have been made.

All agreements, covenants, representations, and warranties, express and implied, oral and written, concerning the rights and responsibilities of Member and PCC are contained herein. No other agreements, covenants, representations or warranties, express and implied, oral and written, have been made by and between the Member and PCC concerning the subject matter herein. All prior and contemporaneous conversations, negotiations, possible and alleged agreements, representations, covenants, and warranties between the Member and PCC herein are merged.
